Tom Ketchum came to meeting to explain the Accident and Sickness coverage for the Fire Dept. Workmen's Comp. Is slow in paying and this policy will pay right away. Motion made by Douglas Allen to accept the Basic 1yr. Plan for the Fire Dept. Seconded by Elmer Ragen. Ayes - 2

Planning - It's pretty slow right now so they are looking over the ordinances and bringing things up to date that there was no time to look at before. Abrams Lumber needs State approved plans and they need exhaust fans in the building. This is being looked into by the Chairman. County is looking at different roads and lanes and these will be changed as needed in the township.

Park – Took lawn mower in and got new blades and had it checked over. There is a couple of Tournaments in the near future. Will get Building specs to go out on bids.

Fire Dept. – Pond on Allen Road the town will put chemicals in the pond and it takes 2 weeks to see if it works, wondering if owner would give us

and easement for the pond like the Allen's did 10 yrs. Ago. Chairman stated the owner would probably go along with this.

Would like to see the Mobile Home Park have each lot numbered so any emergency vehicles can tell which house to go too. Also would like to see the house numbers out by their drive-ways on private roads. Chairman stated this is being taken care of right now.
